### 1. Internal Motions

## **2. Motions Relating to the BPSA Constitution and Regulations**

- 2.1. - 2.2. This association believes that regulations should be changed set out in the "76<sup>th</sup> Annual Conference Supplement 1" including verbal and written recommendations." (2018)
- 2.3. This association believes that changes to section 5 of the BPSA Regulations 'Executive Elections' passed at the 76th. (2018)
- 2.4. This association believes that during the executive elections there should be an opportunity for members to give verified objective factual information. (2018)
- 2.5. This association believes that a subcommittee should be convened to review the aims, structure, and ways of working of the Association and its Executive and to report their findings at Annual Conference. (2018)
- 2.6. This Association believes that the Executive may vote, with a two thirds majority of Executive members present and voting, and a quorum of at least two thirds of Executive members, to remove a member of the Executive from their position, the timing to be decided by those present and voting. The Executive member facing the vote of no confidence may not take part. All other members of the Executive shall be invited and sufficient provisions made to allow them to attend. Executive members may vote either for or against removal and may not abstain. The chair shall not vote. All votes shall be secret but counted for the minutes of the Association. This motion shall take effect immediately. (2019)
- 2.7. The Association's Executive 2019-20 should consider the feasibility for an unofficial 20th Executive member, recruited via cooption, to act on the recommendations of the outgoing 2018-19 Executive. (2019)

## **3. Motions Relating to the Pharmacy Degree**

- 3.1. This association believes that schools of pharmacy should promote interprofessional learning (IPL) through academic and social activities with other healthcare students. (2017)
- 3.2. This association believes that a Dementia Friends workshop should be run at all Schools of Pharmacy. (2017)

- 3.3. This association believes that the pharmacy course should introduce upcoming technologies such as personalised medicines and pharmacogenetics into the curriculum that will affect current and future pharmacists. (2017)
- 3.4. This association believes that all undergraduate pharmacy degrees should include patient centred examinations in each year of study. (2017)
- 3.5. This association believes that the BPSA should liaise with ABPI, Academy of Pharmaceutical Sciences, RPS, and individual pharmaceutical companies to try and increase the number of industrial placements and pre-registration places available across the UK. (2017)
- 3.6. This association believes that more information should be available to students on the many available pharmacy careers that exist beyond community, hospital and primary care. (2017)
- 3.7. This association believes that schools of pharmacy should raise awareness of the Institute for Healthcare Improvement and their work. (2017)
- 3.8. This association believes that schools of pharmacy should require MPharm students to re-sign the code of conduct at least once each year. (2017)
- 3.9. This association believes that pharmacy schools should do more to teach students about safeguarding. (2018)
- 3.10. This association believes that pharmacy foundation students should be able to be involved in Association events. (2018)
- 3.11. SoPs should incorporate business and enterprise into their curricula. (2018)
- 3.12. This Association believes that the MPharm curriculum should teach students how to recognise and respond to mental health conditions. (2018)
- 3.13. This Association believes that herbal and natural medicines should be included in pharmacy education to a greater extent, to challenge misconceptions and promote greater research. (2019)
