# **BPSA Executive Update July 2020**

Dear members, sponsors, stakeholders and supporters,

We hope you are managing well during this challenging time. Given the unprecedented circumstances we find ourselves in, we have had to make some changes to the normal running of the Association.

You may be aware that recently the BPSA held an Extraordinary General Meeting (EGM). As the name suggests, this is not something that happens regularly, so we are very grateful to all of our members who took the time to join us in the EGM. During the meeting the following motion was passed: "The Association believes that the 2019-20 Executive has the authority to make reasonable adjustments to the Executive and the Association, as agreed by the delegation at an EGM held during the COVID-19 pandemic, in response to the COVID-19 pandemic." This means that we can make decisions to ensure that members are best supported and the BPSA is protected.

#### **Provisionally Registered Pharmacists**

Usually, BPSA membership is only available to students currently undertaking an accredited MPharm course or pre-registration training programme in Great Britain. Owing to the current circumstances, a large proportion of our work in last few months has consisted of working with the GPhC and other key stakeholders to create and finalise the requirements, decisions and guidance for current Pre-registration Pharmacists who will be enrolling onto the register in the coming weeks as provisionally registered Pharmacists. The Executive has decided that until the 1<sup>st</sup> of July 2021, provisionally registered pharmacists will also be covered by our membership. This means that we will engage with, represent and advocate for provisionally registered members at all stakeholder meetings and provide support and direction. However these members will not be eligible to run for a position in the April 2021 elections. #### **Executive positions**

Each BPSA Executive member is elected to their role for one year, usually at our Annual Conference in April, which we were unable to hold due to the ongoing pandemic. As a result of the postponed election process, and to create consistency during this period of disruption, it was decided that one of the reasonable adjustments made this year will be the continuation of the 2019/20 Executive's mandate until an appropriate time for elections to take place. We are hoping that this will take place online in September.
